- 1. <u>Please be sure to bring your **Examination Card**</u> and wear a mask when taking the examination.
- 2. Be sure to turn off the mobile phone etc. before entering the waiting room and examination room. (Please cancel the setting of the alarm. The alarm may sound even if the power is turned off.) You can not use a mobile phone etc. for the waiting time of the oral examination.
- 3. Mobile phones etc. can not be used instead of a watch.
- 4. If you arrive 30 minutes after the examination starts, you can not take the examination.
- 5. There is no clock in the examination room. Please be sure to bring your watch. If you forget a watch, please offer to have the supervisor show you the watch if necessary.
- 6. You can not enter the school building for previewing.
- 7. We do not offer accommodation in our university.
- 8. Please keep your Examination Card carefully.
- 9. The timetable of the oral examination will be announced on the day of the examination. Please plan your return transportation with room for adjustment.
- 10. The projector prepared at university has the HDMI port and the VGA port (D-Sub 15 pin). On the day, prepare an adapter etc. if it is necessary to connect the brought laptop to the HDMI port or the VGA port. We do not lend the adapter at the university (Student Affairs Group).
- 11. When entering the examination building, disinfect your hands with the alcohol provided. If alcohol disinfection is difficult for some reason, the applicants should prepare an alternative and disinfect the hands.
- 12. The following applicants are not allowed to take the examination. If you are unable to take the examination on the day of the examination for these reasons, please contact the Admission Office by 1:00 p.m.(Japan standard time) on the day of the examination.
 - (1) Patients with COVID-19 who are hospitalized or undergoing treatment at home or in a residential facility on the examination date.
 - (2) Those who have been requested by a public health center to observe their health and

refrain from going out as a person in close contact with patients with COVID-19.*

- *However, those who meet all of the following requirements may be able to take the examination with the permission of the Admissions Office, even if you become a person in close contact with COVID-19 patients.
- If you meet these requirements and wish to take the examination, please contact the Admissions Office (0265-77-1310) by 10:00 a.m.(Japan standard time) the day before the examination.
- 1.Your results of the initial screening (PCR and other tests (administrative tests) conducted by the local government or a medical institution instructed by the local government) must be negative.
- 2. You are asymptomatic on the day of the examination.
- 3.You will not use public transportation (train, bus, taxi, airplane (domestic flight), passenger ship, etc.) and will avoid crowded places to come to the Venue.
- (3) Those who are in the isolation after entering Japan from overseas to take the examination.
- (4) Those who have consulted with their family doctor or the "consultation/consultation center" (the name may vary depending on the region; hereinafter referred to as "family doctor, etc.") and canceled the test on the day of the test.

*Suggestions for symptoms to consult with your family doctor are as follows.

- ① If you have any of the strong symptoms such as shortness of breath (dyspnea), strong fatigue (fatigue), high fever, etc. on the day of the test
- ② Among examinees who are likely to become severe due to underlying diseases, etc., and who have relatively mild cold symptoms such as fever and cough
- 3 When relatively mild cold symptoms such as fever and cough persist
- (5) On the day of the examination, those who meet at least one item in column A or two items in column B of the following health condition checklist.


